CONSOLIDATED REPORT ON AMINATOU MBOLE'S MEDICAL EMERGENCY AND

POSTHUMOUS ARRANGEMENTS

I. MEDICAL HISTORY AND CIRCUMSTANCES

Aminatou Mbole was hospitalized for over three months due to meningitis complications. Initially managing her condition privately, she faced significant challenges when requiring her first brain surgery. Despite various interventions and a second surgical procedure, her condition deteriorated, leading to her passing on November 16th, 2024.

II. ADMINISTRATIVE MANAGEMENT

The situation presented multiple administrative challenges, primarily with the hospital administration regarding an outstanding bill of over 3.7 million pesos. The hospital's refusal to release a death certificate without full payment or promissory note created a complex situation, particularly in accessing employment benefits and insurance claims.

After extensive deliberations and consultation with her family, cremation was authorized as the most practical solution. Her ashes are currently stored at the Makati Episcopal Church columbarium pending final arrangements.

III. COMMUNITY RESPONSE

The community's response was immediate and substantial, manifesting through multiple fundraising channels including:
